\*Certain restrictions apply. The lenders interest rate must not be supported by any third-party arrangements such as vehicle subvention (with rates as low as 0.0% APR), other manufacturer discounts, rate buy-downs by car buying services, or any other similar third-party subsidized rate offerings. The lenders interest rate must be generally available to all customers who share a similar credit risk profile (employee-discount programs or other special, limited lending programs would not qualify). NMFCU will offer a rate that is .25 percentage points below the specific rate and term offered by a competing lender.



### BONUS DIVIDEND 4th Quarter 2023

In staying true to our mission of serving only our members and being not-for-profit, the Board of Directors has declared a 0.50% APY Bonus Dividend on all qualifying share/savings accounts on deposit from October 1, 2023 thru December 31, 2023.
